### 01. PURPOSE

## 02. ESG POLICY

#### 01) Zero Fatality

As a company specializing in material technology for user safety and comfort, HAMC's business aims to minimize accidents and human damage in industries where our products are applied. Our goal is to expand our products' safety beyond our direct customers ensuring customers' customers and end-product users safe and comfortable.

#### 02) Zero Emission

In order to respond to and adapt to climate change, the caompany strives to minimize emissions from the energy input to the process as well as the sourcing of raw and subsidiary materials, product transportation, and product use and disposal. We actively participate in global climate change initiatives, activate circular economy, improve energy efficiency and convert to renewable energy, manage product carbon footprints, and manage the emissions of our suppliers.

- (1) Set and implement a 1.5 degree reduction target for all business sites.
- (2) Strive to calculate and reduce LCA for key major products.
- (3) Develop and supply products that consider the stages of use and disposal.

In order to solve the resource depletion problem, we strive to reduce input resource (ex. raw material) and increase output value(ex. products & services). To this end, we minimize defects and waste in the process, increase recycling of raw and subsidiary materials, and actively introduce conversion to eco-friendly materials.
